



City of Tomah COVID-19 FAQ's

Is City Hall open? City Hall is open for absentee voting/voter registration only at this time during limited hours. Tax payments, water payments, citation payments, ambulance bill payments, permit fees, etc. may be made on line on our website, dropped in the drop box, or mailed in.

Can I register to vote if I am not currently registered? You can go online to myvote.wi.gov to register if your driver's license or WI ID are current. You may also come into City Hall to register in person at the designated hours (Monday through Friday 10 a.m. to 11 a.m. and 2:30 p.m. to 3:30 p.m. or by appointment). You can also register to vote on Election Day with appropriate proof of residency.

How can I obtain an absentee ballot if I am a registered voter?

Go online to <https://myvote.wi.gov>.

Submit an e-mail with request stating name, address, Election you are requesting a ballot for along with a copy of your photo ID and we will mail you an absentee ballot if you are registered.

Put a request in writing in the drop box along with a copy of the photo ID and we will mail it out.

Appear in person between 10 a.m. and 11 a.m. and 2:30 p.m. to 3:30 p.m. daily (until further notice) Monday through Friday. The only business conducted in City Hall at that time is absentee voting.

What is the deadline for liquor license renewals? The deadline for submitting liquor license renewals for local establishments is extended to April 10th at this time. If you want to submit your paperwork, you can do so by mail or in the drop box at City Hall. Please remember to include a copy of your WI Seller's Permit. Bartender license renewals don't have to be done until May – you may drop them off in the drop box also with payment if you want to take care of it sooner.

How do I complete applications and permits? Farmers Market, Transient Merchant, Taxi Cab drivers, etc. permits – applications are available on the website at www.tomahonline.com. Forms and payments may be dropped off in the drop box at the front entrance of City Hall or mailed in to City of Tomah, 819 Superior Avenue, Tomah, WI 54660. We will process as we get them.

How do I purchase a pet license? You can purchase a dog or cat license by mail or by dropping the information off in the City of Tomah drop box by the front door. Make sure to include a self-addressed stamped envelope along with the paperwork showing your pet's current rabies vaccination. Pet licenses are due by March 31st.

How can I pay my real estate taxes? There are several ways you can pay your taxes. You can mail us your payment. Please make sure the postmark is by March 31st. You can drop off the payment in our drop box by the front door at City Hall. You may also go to www.tomahonline.com and pay through GovPay under the Payment Tab. There is a charge to pay this way. The City has no control over the due dates for taxes. The last day to pay your taxes without penalty is April 7th. This means that your payment must be in our office that day, not in the mail. Please include a self-addressed stamped envelope if you would like a receipt.
